Merge onto Westchester Ave/NY-119/County Hwy-62 via EXIT 26W toward I-287 W/White Plains.

Merge onto I-287 W/Cross Westchester Expy W toward White Plains/Tappan Zee Brg

Take the Central Westchester Pkwy exit, EXIT 7.

Merge onto County Hwy-150/Central Westchester Pkwy.

County Hwy-150/Central Westchester Pkwy becomes NY-22. (bear right)

Turn right onto Orchard Dr. (Orchard Dr becomes Old Orchard Dr)

- Orchard Dr is 0.7 miles past Kensico Dam

There is a long driveway to the school at the turn to Old Orchard Dr which will be marked

From Tappan Zee:

Merge onto I-87 S/I-287 E/New York Trwy S

Keep left to take I-287 E/Cross Westchester Expy E White Plains/Rye.

Take the NY-22 exit, EXIT 6, toward North White Plains.

Turn left onto N Broadway/NY-22/County Hwy-87. Continue to follow NY-22.

Turn right onto Orchard Dr. (Orchard Dr becomes Old Orchard Dr)

- Orchard Dr is 0.7 miles past Kensico Dam
